The Armed Police Force, Nepal Welfare Service Center invites *electronic* bids from eligible bidders for the procurement of *below mentioned Goods* for fiscal Year 2081/082 under National competitive bidding single stage two envelope procedures specified in Public Procurement Act and Regulations.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 23 of the Bidding Document.

5. Pre-bid meeting shall be held at The Armed Police Force, Nepal Welfare Service Center, Halchowk, Kathmandu, Nepal at 13:00 hrs. 2081/05/07.
6. Bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 noon on 2081/05/23 Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2081/05/23 at the office of Armed Police Force, Nepal Welfare Service Center, Halchowk, Kathmandu, Nepal. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum below mentioned respective column. Which shall be valid for 30 days beyond the validity period of the bid. (i.e. Date 2081/09/21, 5<sup>th</sup> Jan. 2025).
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
